This is the plan for those would find new distributor in Japan All non-residential producers, brokers can apply in this format with the application form in English language version.

#### ■ EXHIBITION Period and Venue

- •JULE 20, 21, 22 for 3 days 10AM-9PM(i.e by 8PM on 21st)
- ·Same Venue of "OLIVE MARKET" on7th Floor of SEIBU Department Store
- •Organizer provide plain table without any decoration, so you can decorate your stand table as you like. (decoration plan and materials must have prior approval by the organizer)
- ·Almost all of Japanese olive oil traders and importers will participate and visit the venue.
- ·over 300,000 consumers, traders and distributors will attend the show.

#### **■** FEE

- •Total amount for your exhibition should be JPY 108,000.
- •The payment will be accepted when you apply and there is no refund by any reason After you applied.
- •The delivery costs to exhibit goods and moving out the samples and goods should be paid by Applicant.
